In cases of a declined or expired credit card, we will attempt to notify you via any means provided to us on the dancer's registration form. However, it is your responsibility to contact our office with any credit card changes or your account will be subject to a \$10 *per month* late fee until your balance is paid in full. Checks returned to us by our bank for any reason will accrue a \$35 service charge. We currently **DO NOT** accept American Express Credit Cards and appreciate your flexibility.

If an account balance is carried more than 30 days, SKDP reserves the right to terminate the dancer's enrollment in a	any class.

RECITAL COSTUMES: If a dancer is NOT dancing in our 2025 Recital, it must be noted at the time of registration. Recital costumes are required if your child is performing in our 11th Annual Dance Recital which is held in early June. The costume payment is broken into two installments for your convenience. The first costume installment of \$55 per costume is due on November 15, 2024 (half of costume total); the final installment is due on January 15, 2025 (costume balance). Costumes for the 2024-2025 dance season are <u>\$110 per costume</u> and include all accessories and tights.

## Costume payments are NOT refundable for any reason once the first payment is made on November 15, 2024.

Costumes are not fully ordered without payment. If full payment is not received by January 15, 2025, we cannot guarantee a dancer a costume in time for pictures and/or recital. Late fees of \$15 per costume will be incurred if payment is received after the final installment due date; all additional expenses incurred by SKDP for costumes with payments received after final installment due date will be passed on to parent/guardian of the dancer. Late payments of final installment only will be refunded if costume can no longer be ordered. Dancers without a costume cannot participate in pictures or June's recital. Any alterations are to be completed and at the expense of the parent/guardian. If the costume does not fit, there will be a \$25 exchange fee. We cannot guarantee the next size will come in on time.

Costumes will only be distributed when total account balance is paid in full and tuition is paid through March; if payment for an account balance is remitted by check for costumes, the check must clear before costumes are released or another method of payment must be given. Costumes will not be distributed without the proper dance shoes. I understand the Studio's costume policy.

DANCEWEAR & SHOES FOR CLASS: Studio K Dance Project does not require a specific uniform, but please make sure your dancer has the proper attire and shoes for class each week. Intro to Dance and Ballet & Tap Classes ages 18 months - Age 10: Dancers should wear a leotard or ballet dress and tights as well as pink Ballet shoes and White Tap shoes. All Contemporary Ballet & Tap classes ages 10+: Dancers should wear a leotard and tights/leggings/shorts as well as pink Ballet shoes and black Tap shoes. All Hip Hop & Acro classes: Dancers should wear dark leggings, tank top and black Hip Hop sneakers. *Musical Theater Performance Class*: Dancers should wear a leotard and tights/leggings and black jazz shoes.

If your dancer has shoes that are not the correct color for the recital, you will be required to purchase the proper shoes by March 15, 2025. Costumes will not be distributed until dancers have the proper shoes. I understand the Studio's dancewear and shoe policy.

**CANCELLATION POLICY**: A dancer may withdraw from a class by notifying Miss Katherine in writing prior to the beginning of the month. Cancellation must be presented in writing before the 1st of the month, or you will be responsible for the next month's tuition payment. The \$25 Registration Fee is non-refundable, and the last tuition installment is non-refundable after November 1, 2024.

I understand and accept the Studio's cancellation policy.

I hereby permit my child to participate in any dance tricks, jumps, leaps, etc. and understand the inherent risks in such activities. I release SKDP and its staff from all legal liability and medical cost arising due to any injury incurred during instruction or participation in a SKDP related activity. I release rights to all photos and videos taken in relation to SKDP, for exclusive SKDP use in promotion or advertising. I agree to allow my child to participate in the end of year recital (unless otherwise noted).

AGREEMENT: I hereby enroll my child at Studio K Dance Project for the 2024-205 Dance Season which ends on June 14, 2025. I have read and agree to all policies, terms, and conditions as stated in SKDP's literature. I understand that my dancer is committing to participate in Season 11, and I understand that I am financially responsible to pay for the entire dance season. I fully understand all the above statements on this registration form, and therefore am registering my dancer for the 2024-2025 dance season at Studio K Dance Project.
